

Assumption of Risk Agreement

Outdoor & Non-Facility Training · Required for Parks / Home Sessions

I freely, knowingly, and voluntarily assume all risk of injury, illness, death, or property damage arising from participation in outdoor and non-facility training with Green Eye Open. This agreement is specific to training sessions conducted outside of traditional gym facilities — including city parks, trails, and private residences. It supplements (and does not replace) the Liability Waiver (GEO-01). This assumption applies to risks both currently known and those that may not be fully foreseeable, to the extent permitted under Wisconsin law. I acknowledge that I had the opportunity to ask questions about these risks before signing this document.

ENVIRONMENTAL RISKS

- Uneven, slippery, or unstable terrain
- Weather-related hazards (heat, cold, precipitation, lightning, wind)
- Sun exposure and dehydration risks
- Insects, wildlife, or allergens
- Limited shade, shelter, or restrooms
- Motor vehicle traffic near training areas

SAFETY & EQUIPMENT RISKS

- No emergency medical staff or AED on-site
- No lifeguard if training near water
- Limited or no access to running water
- Equipment brought to location may differ from facility equipment
- Delayed emergency response times vs. facility settings
- Unpredictable third parties (other park users)

Home & Private Residence Specific Terms

When training at my home or private residence, I affirm that:

- I have inspected the designated training area and believe it to be reasonably safe for exercise activities.
- I have disclosed to the Trainer any known hazards at the training location (e.g., unstable flooring, low ceilings, obstructions, pets).
- I am responsible for ensuring the training area is cleared and safe before each session.
- I understand the Trainer is not liable for damage to my property that occurs during the normal course of training.
- I have a working phone available for emergency calls during each session.

Emergency Protocols

I understand that in the event of a medical emergency during an outdoor or home-based session, Paul Gover will: (1) call 911 immediately if warranted; (2) administer basic first aid within his training and certification; (3) contact my emergency contact using the information on file. I accept that emergency response times may be slower in non-facility environments and voluntarily accept this risk.
